

FOREWORD FROM THE EXECUTIVE DIRECTOR



The last two and half years have been one of the most challenging times in modern Oromo history. Beginning with the murder of Haacaaluu Hundessa in 2020 and the mass arrest of prominent political prisoners, in a short amount of time, the Oromo have lost thousands of the innocent youth who led the peaceful, pro-democracy protests that brought the current government into power. Revolution turned against those who made change possible.

Since OLLAA was formed in 2016, our core mission has been to raise Oromo voices and be a force for human rights, women's rights, and indigenous rights by empowering Oromo communities in Ethiopia and across the globe. Over the past year, we have witnessed the situation facing the Oromo become ever more difficult - from escalating conflicts, government-led drone attacks, and dire drought conditions, the humanitarian and human rights situation in Oromia has never been worse.

OLLAA has worked tirelessly over the past 12 months to tell the too-often overlooked stories of the Oromo, to share the plight and tragedy facing millions. We have advocated for more global attention and responses to the human rights violations taking place, including participating in high-level meetings with the United Nations International Commission of Human Rights Experts on Ethiopia (ICHREE), with government bodies, the United Nations, the US State Department, civil society organizations, and much more. Much of this advocacy work takes place behind the scenes, but it is this essential work that keeps the Oromo present in conversations. In the following report, you will find a comprehensive compilation of OLLAA's publications over the past year. While this only represents half of the work we do, the articles, press releases, events, and more that you will find here are the result of countless hours of work, expertise, and a true passion for human rights and the Oromo people.

It is important to note that the deadly legacy of 2022 is not only the thousands of civilians that have been targeted by drones, heavy military shelling, drought, and mass starvation due to conflict and man-made displacement. Instead, for the first time in modern history, the horror of what the Oromo have long read or heard about in textbooks has become the norm. What was once debated as folklore has now become a tragically common and gruesome sight on live videos disseminated across social media sites: videos depicting the breasts and hands of Oromo farmers being cut off, and Oromos being beheaded and burned alive.

For the Oromo, the most heartbreaking aspect is that it is happening under the guise of those who claim to be Oromo. Merely four years ago, over 5000 Oromo lost their lives to bring about change - however, those who came to power due to those peaceful revolutionaries not only appear more anti-Oromo than Orommuma (Oromo culture and nationalism), hey are complicit in actions that violate the very foundations of human dignity and human rights that they are sworn to protect.

For those in the diaspora that have given so much from afar, these latest atrocities have been extremely painful. It is painful partly because those who are now targeting Oromos were once the very same people many placed their hopes into. On top of this, and perhaps most painfully, is the fact that the international community has continually refused to condemn the atrocities against the Oromo, sending a message that Oromo lives matter less. To the Oromo, the Pretoria peace agreement signed in November to end the civil war in the North seems to have let Prime Minister Abiy Ahmed off the hook - sending the message that as long as he can make peace with Tigray, the West, and, in particular, the United States, will not make mention of the atrocities occurring in Oromia.

With this ambivalent legacy serving as our backdrop, I look forward to 2023 with both fear and hope. Fear that the international community's silence in the face of brutal acts of violence will continue - such as when Oromos are burned alive on camera, beheaded. or killed in mass - emboldening the Abiy administration to commit further atrocities. Yet, hope still blossoms from the strength of the Oromo people to stand together in the pursuit of dignity, human rights, democracy, and justice. The barbaric acts committed against the Oromo by the current ruling parties have united the diasporas and Oromo more than ever - and it is through this unity that Oromos can speak with a strong voice: calling for an end to violence and oppression and building a road to peace.

It is this road to peace that OLLAA is committed to working towards in 2023. We thank you for your support over this difficult last year and look with hope as we take our first steps into the new year together.

As the Oromo proverb says, "Through unity, fibers can tie an elephant" (Qunceen wal gargaartee arba hiiti).

OLLAA Exclusives contains publications covering high-level topics on the Oromo community. OLLAA Exclusives offer the greatest top-down perspective on current policies in Ethiopia and abroad while still condensing complicated issues into summary form. OLLAA Exclusives are created by OLLAA internally by subject matter experts.

Press Releases catalogs relevant news articles to the Oromo and diaspora from reputable news sources including but not limited to: Reuters, the United Nations, Bloomberg, BBC, USAID, and more. Topics covered in Press Releases relate to the humanitarian crisis facing the Oromo community, ongoing tragedies relating to the armed conflict in the region, and paramilitary activities and their effects on the local population in addition to much more.

Humans of Oromia is the section where articles come from reliable "boots on the ground" sources, that is, individuals who live in regions of tension or conflict within Oromia or elsewhere in which citation from primary sourcing is the only reliable method of conveying the present situation and circumstance. More so, Humans of Oromia provides individuals the chance to share their experiences and relate ongoing suffering while still providing a unique scope of coverage analyzed by experts.

Events is the section in which events hosted by OLLAA in which previous events are listed. Within Events a description of the event is given if relevant as well as links to any related social media. OLLAA EXCLUSIVES

The Long Arm of the Ethiopian Government in Kenya | January 5, 2022

"Kenya is home to a significant number of Oromo-Kenyans, as well as Ethiopian refugees predominantly originating from the Oromia and Ogaden regions of Ethiopia. According to the Danish Refugee Council (DFC), these refugees are typically fleeing political persecution and "escaping harsh, oppressive and undesirable conditions." As the conflict in Ethiopia escalates, and as OLLAA has been documenting, thousands of Oromo civilians and political opponents face violent government targeting and arrest. With so many fleeing their homes in fear of their lives, OLLAA is deeply concerned by reports of the unwelcoming and obstructive practices currently in place." Read more here.

Retaliatory Attacks Against Civilians in Oromia | January 17, 2022

"In recent weeks, OLLAA has received several reports of civilians being targeted by Ethiopian State agents, including members of the military and police, in the East Guji, East Wollega, and Kellem Wollega zones of Oromia regions. These attacks have involved both physical attacks against individuals, in some cases leading to death, and the intentional burning down of their houses, leading to forced displacement. Many of these attacks were apparently made as a form of retaliation for the ongoing conflict between the Ethiopian military and police and the OLA." Read more here.

A Living Hell: Oromo Migrants Bear the Scars of Houthi Bombing | January 25, 2022

The Houthi bombing that occurred in March of last year, resulting in the death of at least 400 Oromo migrants, exposes the horror that can await some of the most vulnerable individuals in an already devastated region. As we edge closer to the one year anniversary of the tragedy, it is worth taking stock of the current situation in Yemen – and what it portends for those who remain stranded there." It's Time for the International Community to Denounce the Ethiopian Human Rights Commission | February 7, 2022

"The Ethiopian Human Rights Commission (EHRC) is a National Human Rights Institution (NHRI) that was established in 2000. It has a mandate for the promotion and protection of human rights, which enables them to undertake human rights investigations and monitor prisons and public service institutions to ensure that international human rights standards are protected and observed. Since it was established, the EHRC has faced criticism from leading civil society organizations that it lacked independence and was biased. That perception began to change after Prime Minister Abiy Ahmed came to power in 2018, and in 2021, several sources claimed that the EHRC appeared to have improved substantially in recent years. However, following the release of a joint report by the United Nations Office of the High Commissioner for Human Rights (OHCHR) and the EHRC, which was widely viewed as an attempt by the EHRC to create a false equivalency between the scale of violations committed by the Ethiopian, Eritrean, Amharan forces and the TPLF, it appears the international community is again coming to recognize the failures of that body." Along the Eastern Route: In the Footsteps of Ethiopia's Forgotten Slaves | February 25, 2022

"Worn-out flip-flops and calloused feet mark the young men and women making their way along the barren, dusty road from Obock to Aden. It is a trek that takes more than two days on foot, typically under a burning sun that pushes temperatures to 40 °C or more. There is little food or water to be found along the way. Instead, migrants rely on the kindness of locals or the black-and-white survival sacks handed out by the IOM at various checkpoints. According to the IOM, at least 400,000 Ethiopians made this journey to the Arabian Peninsula between 2017 and 2020. Since then, migration has slowed due to COVID-19 border restrictions. However, as these restrictions lift, the migratory flow is predicted to keep on growing. Key drivers such as low employment, ongoing conflicts and natural hazards remain unresolved." Violence and Displacement in Sibu Sire | March 9, 2022

"Sibu Sire woreda is located in the East Wollega zone, Oromia region, approximately 274 km from Ethiopia's capital, Addis Ababa. The most recent population estimates for the woreda were published in 2005 by Ethiopia's Central Statistical Agency, who reported that 97,864 people lived in the woreda, the vast majority of whom are Oromos. Like much of Oromia, Sibu Sire has been subject to frequent internet shutdowns over the past few years. Such shutdowns have made it difficult for individuals on the ground to share reports of human rights violations, including, most recently, a series of attacks perpetrated by Amhara militias which reportedly led to the mass displacement of roughly 15% of the population of Sibu Sire." Oromia in Peril: The 8 Million Ethiopians Facing Hunger & Drought | April 28, 2022

"Since the civil war broke out in Tigray in November 2020, the world's attention has turned to the humanitarian crisis in northern Ethiopia, caused, in large part, by the defacto blockade on the delivery of humanitarian aid. In recent weeks, the TPLF and the Ethiopian government have adopted a humanitarian truce designed to allow the flow of humanitarian aid into the region. While this is certainly welcome news for civilians throughout northern Ethiopia, it does not alleviate the suffering of Ethiopian citizens throughout the rest of the country, particularly in the south, which has been experiencing increasing food insecurity due to a drought, which some have called the "worst drought in forty years", alongside underreported conflicts." A Mother's Heartbreak | May 10, 2022

"The last time Degalee saw her youngest child, then a seven-month-old baby, the foundations of her life had just come crashing down. Three days earlier, Ethiopian security forces seized Degalee's husband and killed him in front of her and their six children in their own home. As her husband was murdered, Degalee recounts how she was forced to stretch out her body in front of her children – a human barricade to prevent them from risking their lives by running to their father. It was 2012, a period of extreme crackdowns by the then-government on any perceived opposition to their regime. Many ethnic Oromos were arrested or killed for their supposed links to the opposition party, the Oromo Liberation Front (OLF). In the days after the attack, knowing that the security forces would return for her, Degalee was forced to flee her home, leaving her children behind in the hope they would be protected from further retribution. Not knowing where she was going and simply fleeing for her life, Degalee found herself sucked into a tragedy of human trafficking, exploitation, and hardship that continues to this day." OLLAA: Report on Extrajudicial Killings in May 2022 | June 30, 2022

"As the ethnic onslaught continues upon Oromia, civilians continue to face extrajudicial executions at the hands of security forces. May was a bloody month for the Oromo people, with 35 reported civilian deaths at the hands of Ethiopian security forces, reproduced below. Security forces often accuse civilians who they have killed without due process of law of having been a member of the Oromo Liberation Army (OLA) or being related with or otherwise connected to members of the OLA, despite such connections often being tenuous at best."

Death By Starvation | August 3, 2022

"As previously reported by OLLAA, the southern regions of Ethiopia are experiencing increasing food insecurity and starvation due to drought, conflict, and other factors. Since OLLAA last examined the effects of the drought on Oromo civilians in April 2022, we have received further updates about the extent of humanitarian needs in Oromia, both from publicly available sources and credible sources on the ground. We are particularly concerned about the latest report that 38,000 people in the Sabaa Borruu district of the Guji zone are currently facing acute starvation. This report will, therefore, provide an update on what is known about the extent of humanitarian need inside Oromia. Taken together, these sources reveal that the Ethiopian government and the international community may be severely underestimating the true extent of humanitarian need across Oromia." "July has been another bloody month for the people of Oromo, bringing further reports of extrajudicial killings and attacks against civilians to the region, as government forces continue to target Oromo citizens, often alleging they are OLA supporters. The data collected below details individuals who were reported by the mass media as having been extrajudicially killed by Ethiopian government security forces in July throughout Oromia." 
